## STAND BUILDING DOCUMENTATION INFORMATION

#### 1. Basic stand

is a stand with specifications in conformity with Point II.1. Stand Construction Rules of the Rules and Regulations of Operation as follows, i.e.

- the stand is constructed on covered area
- the stand is constructed from prefabricated standard material (e.g.: Syma, Octanorm, etc.),
- the stand is constructed on no more than 50 sqm, including the building, lighting structure, company fascia
- its height does not exceed 3.00 m, and the corporate signature or logo to be placed exclusively within a 1.00-metre strip along the inside of the stand walls – is not higher than 3.50 m,
- there is max 2 pcs of max. 4,5-metre high towers, on 1 sqm floorspace
- its electric consumption does not exceed 5 kW (3x10 A) including that of exhibits operated on the stand
- there is only one water connection, with size of 1/2",
- the fire protection class of the flooring is minimum C<sub>fl</sub>-s1.

it is enough to return the statement in Point I. of the form duly signed.

- **2. In the case of a custom-built stand**, please mail the present form and all the documentation listed in Chapter II. Stand Construction Rules of the Rules and Regulations of Operation. The name and the number of the designer's licence should be indicated in the form.
  - The technical contents of the documentation to be mailed should meet the relevant EU and Hungarian standards, standing regulations and design principles. HUNGEXPO C.Co. Ltd. is not responsible for any damage arising from plans which are incomplete, submitted after the deadline or not suitable for approval.
- 3. The Exhibitor is responsible for the stability of the stand built on his/her rented area, as well as for any material and immaterial damage caused by a lack thereof.
- **4.** In case of **multi-storey stands** the written declarations of consent of the neighbours should be attached to the stand construction documentation.
- **5.** The built-up area of a stand built in an **open area** must not exceed 70% of the rented area. A clearance of at least 2.00 meters from the neighbouring area must be maintained. (See Point II.1.17. of Stand Construction Rules of the Rules and Regulations of Operation.)
- **6.** In case you wish to place only a caravan, tent, self-propelled machine, vehicle or container **in the open area**, it is enough in addition to mailing the duly signed statement in Point I. of the form to submit a **sketch floor plan including height measurements**.
- **7.** When erecting a basic stand, the designer or the builder must make a written declaration that work safety criteria are met and the work is organised with due regard to ergonomic considerations.
- 8. Please contact the relevant member of the Exhibition Co-ordination Unit before occupying the area in order to specify the leased exhibition area on the spot, clarify conditions for work, and receive approved documentation. If HUNGEXPO C.Co. Ltd. has added comments to the approved design, and further co-ordination or clarification is required, please contact HUNGEXPO C.Co. Ltd.'s Exhibition Co-ordination Unit or Security Unit.
- **9.** In case of constructing a building in an open area, the rules of the official licensing procedure in force should always be adhered to.
